National Road Festival Artisan's Street Fair Vendor Information Sheet

GENERAL INFORMATION:

The National Road Festival Artisan's Street Fair will be held in downtown Casey on old Route 40 (Main Street of Casey, IL), the Historic National Road. The Fair runs from 9am-7pm on Saturday June 19th, 2010.

FEE:

Each artist is asked to donate at least one original work of art to be auctioned at the fundraising auction to be held that afternoon. Donated items should have a minimum retail value of \$50.00. A space fee of \$50.00 due before set up will be charged to any artist that chooses not to donate an original work of art. Tables will be available to rent at \$20.00 each. Please indicate how many tables you need and if you need access to electrical hook up on the artist application.

JURYING/APPLICATION DEADLINE INFORMATION:

In order to ensure high quality of workmanship, variety, and uniqueness of entries, all work will be juried into this fair. All submitted items **MUST** be handmade and original by the applicant. . All artwork must be represented in photographs, mailed or emailed. The deadline for submission is May 31st, 2010, however, media publicity for this event will begin April 15th. All applicants received by this date will be included in the festival's Artisans Fair flyer/brochure.

SET UP/CLEAN UP INFORMATION:

Accepted artists will be able to set up starting at 6:30 am the morning of the event. Set up must be complete by 9am. Booths must remain open for the entire length of the Fair from 9am to 7pm. Clean up will take place from 7-8pm. The City of Casey or festival committee will not be responsible for accidents, theft, loss, or acts of vandalism.

TABLES AND SPECIAL ACCOMODATIONS:

Each vendor will need to bring their own supplies and equipment. Tents may be used but must be substantially staked and/or weighted in case of sudden changes in the weather as this is an outdoor festival. Spaces will be set up on each side of the festival route, leaving an open corridor for the 10am parade route. Tables will be available for rent at \$20.00 each. Please indicate on application if you will need electricity hook up.
